The Workshop and Forum will present speakers from Government, the Social Enterprise Sector including key intermediary organisations and provide case studies relevant to Local Government. AM: Introduction to Social Enterprise as an economic contributor to a local Government agenda

PM: Investment, economics, governance and community ownership of Social Enterprise in Local Government

Presentation and discussion on the potential for Local Government to build economic community wealth though pathways to market and value-based ventures. The afternoon session will explore investment and governance systems including Council supported NFP associations &/or cooperatives.
